#### **1. Our next function:** An announcement:

MAB Managing Committee takes pleasure in announcing that its next Annual function will be held on **SUNDAY, 28<sup>th</sup> January, 2007** from 10.30 a.m. onwards (as per programme) at:

#### **Lawns of Guest House at Aarey Milk Colony, Goregaon (E), Mumbai**

In response to popular demand in favor of providing varying venues for our Functions, it has been possible this time to arrange the above beautiful venue with kind help and patronage from a well wisher in the Biradri. We are sure members will like the location for a good change and enjoy the function in the open, lush green and shaded surroundings.

*With only one central Mathur Function a year, we are sure you will not like to miss it, not only because of a new location this time, but also as the next chance of your meeting the Mumbai Mathur Biradri will, most likely, be only after one full year.*

#### **A – APPROACH:**

Aarey Milk Colony at Goregaon (E) itself is a very well known place, needing no big approach directions. Goregaon on the Western and Kanjur Marg on the Central Railways are the nearest Suburban stations if one is coming by a local train. It has two checkpoints (CP-1 and CP-2) for entry. CP-1 is for entry from Powai / Saki Naka / Marol side and CP-2 from the Western Express Highway at Goregaon (E) side.

The Guest House, situated at an elevation in the heart of the vast acres, is about 2.5 kms., inside from the CP-1 and about 3.9 kms. inside from CP-2 by internal road and can be reached by private cars, taxis or autos from either side right upto its gate. Those coming by BEST buses from either side may get down at '**Chhota Kashmir**' stop inside the Colony (nearest to the venue) and walk a little to the Guest House gate. Coming from Goregaon side, the gate is on the left and from Powai / Marol side it is on the right of the road.

#### **MAB will provide a vehicle to take people from the gate at the road to up the Guest House.**

The following BEST buses serve the route to the Entry point CP-1 (from Powai / Saki Naka side):

1. No:326 (Kurla-W to Barve Nagar), via Kamani, Saki Naka, Marol Maroshi Road to CCP-1
2. No: 341 (Antop Hill to Goregaon-E), via Koliwada Rly. Station, Kurla Depot, Saki Naka to CP-1
3. No: 460 (Mulund station -W to Gorai Depo), via Bhandup Stn., IIT Market, Powai Garden, Marol Maroshi Road to CP-1
4. No: 489 (Shivaji Nagar Depo. to Dahisar Depot.) via Chheda Nagar, Ram Mahal, Vikhroli Depo, IIT Market, Powai Garden, Marol Maroshi Road to CP-1
5. No. 341 from Goregaon (E) to Aarey Milk Colony (CP-2). Get down at Chhota Kashmir stop.
6. Buses from Andheri(E) towards Saki Naka (except busses to SEEPZ), get down at Marol Naka Fire Station stop and take buses to Aarey Milk Colony CP-2 and get down at Chhota Kashmir Stop.

Note: Bus Nos., remain same in either direction to CP-1 and CP-2

*Zones, specially the far off ones, may think of hiring shared buses as it will be a great convenience to their members in reaching the venue comfortably in a group. The buses will drop & pick up at the gate, but parking may be a little away.*

**B - PROGRAMME:** (maybe a bit flexible, but not too elastic)

- a) 10.30 a.m. to 12 noon: Reception, Registration and a hearty breakfast.
- b) 12 noon to 2 p.m.: Variety progs., games , *cooling & quenching* , etc.
- c) 2 p.m. to 3 p.m.: Lunch (Veg.)
- d) 3 p.m. to 4.30 p.m. Leisure time, gup-shup, Tambola, or whatever else.
- e) 4.30: p.m. “One for the road” – Tea with snacks, followed by “Goodbye till we meet again”

**Please note that the B’fast counter closes at 12 noon. So, if you are late, you would not know what goodies you have missed and it is we who will be sorry for it.**

The formation the MAB Welfare Trust and its Registration under the Charitable Public Trusts Act, along with our having obtained permission for issue of Certificate under Section 80G of I. Tax Act (entitling a donor to claim tax relief) have already been announced in detail in our last two Newsletters. It may be recalled that the main objective of the Trust is to provide emergency medical relief to members in distress, besides other public activities in the field of education, welfare of Senior citizens, etc.

(iv) The purpose of including the mobile nos., will be defeated if these are frequently changed, as it may not be possible for us to monitor or notify frequent / further changes in the mobile nos. in our Newsletters.

c) **Mathurs in Mauritius:** In our Newsletter dated 4<sup>th</sup> January, 2007 we had mentioned about the growing popularity of our website not only with Mathurs in Mumbai and rest of India but also abroad, and a case was cited of a Mathur family shifted to Mauritius about a century ago whose third generation is now settled there as Mauritius citizens. It was also mentioned that after visiting our website, a lady from a Mauritian Mathur family emailed us in a bid to trace their origin in India. A number of our MAB members (including some who have already visited Mauritius) were fascinated to learn about it and expressed their curiosity to know more about them. Some relevant portions from her email dated 11-9-2006 to us are, therefore mentioned below for our member's interest and reading pleasure:

**Quote:** "Pranam ... Thank you very much for the article which I have already forwarded to my sister in France.... My papa is now 80 years and he is the eldest of the Mauritian Mathurs... I do not know much about his past as at that time we never thought of it... but he was a school teacher. My dadaji and dadiji passed away leaving behind my papa, his brothers and sisters when they were all kids... At present he has three sisters and three brothers. Two of my chachaji's are in England and one Phupaji is in France, leaving one chachaji and 2 Phupaji's here... with their children and grand children.... In Mauritius there are two other Mathurs I know of. In all there are 18 born Mathurs living at present in our family tree....." **Unquote**

As an interesting exercise MAB had offered its help in trying to trace her family's origin in India and requested her for at least some basic, rudimentary details (like probable place of origin, any connected Mathur families of the distant past etc.) to start with. She replied that she will consult her sister (in France) expected back in Mauritius, but no further communication has been received so far despite a couple of reminders from us. However, if and when we receive some information from her, we will share it with the members by including it in our future Newsletters, just in case any one of us could help in spotting her family's Indian origin.
